## JOB DESCRIPTION

### General Description

The purpose of this class within the organization is to conduct technical functions associated with inspecting industrial and commercial operations to determine compliance with sewer discharge regulations.

### Duties and Responsibilities

**The functions listed below are those that represent the majority of the time spent working in this class. Management may assign additional functions related to the type of work of the class as necessary.**

- Coordinates the Industrial Pretreatment Program (IPP) industrial inspection program including scheduling and performing routine scheduled and random inspections of industrial dischargers.
- Coordinates the collection of wastewater samples from sewer lines, waste facilities, and industrial facilities.
- Coordinates the collection of water quality samples from water supply sources and other streams in support of both the Water Treatment Plant and the Watershed Protection Plan.
- Prepares logs and reports to document sampling activities.
- Conducts flow monitoring of sewer lines.
- Conducts inspections of commercial dischargers to determine compliance with local and state regulations and/or permits.
- Performs related work as assigned.

### Minimum Education and Experience Requirements:

Requires an Associate's Degree or specialized courses/training equivalent to satisfactory completion of two years of college in municipal or industrial wastewater treatment or closely related studies; Requires two years' experience in water or waste water collection and treatment or closely related experience; Required qualifications may be any equivalent combination of education, training and experience which provides the requisite knowledge, skills and abilities for this job.

### Physical Demands:

Performs medium work that involves walking, standing, stooping or lifting all of the time and also involves exerting between 20 and 50 pounds of force on a regular and recurring basis or exceptional skill, adeptness, and speed in the use of fingers, hands, or limbs in tasks involving very close tolerances or limits of accuracy.
